Teachers follow a direct parent communication plan and keep logs of these communications with these parents. Parents are invited to participate in family engagement events with direct phone calls from Adair County R-1 Staff. Parents and students are also offered extra academic time after school through teacher tutoring programs. Students who are identified as disadvantaged are also provided weekly snack packs through the Adair County R-1 Food Banks. The district has no limited English proficiency students at this time.
