Parents, along with board members, administration, teachers, staff, and other community members, are informed and invited to attend a meeting where the parent and family engagement policy is discussed during the first quarter and again in the spring of every school year. Notice is given via student flier, personal teacher phone calls, school text messaging, and school social media posts. At the spring meeting parents are asked strengths and weaknesses of the plan and these comments if any, along with the needs assessment, and staff input help provide any needed updates for the policy. These needs are recorded and used to modify the new plan.

Everyone who attends the meeting has input, gives feedback, and comes to an agreement about the plan. Documentation of the feedback is kept and the LEA parent and family engagement policy is adjusted accordingly for the school year and implementation is followed. Another meeting is held in the spring of each year to follow up with the implementation of the plan and inform parents of how to access this plan.

Parents are encouraged to be a part of the local education agency plan development as well as participate in the implementation of the plan throughout the year and provide feedback to the Principal and Title I.A Coordinator. Parents are informed and invited to attend the committee meeting via student flier, personal teacher phone calls, school text messaging, and school social media posts. Everyone who attends the meeting has input, gives feedback, and comes to an agreement about the plan. Documentation of the feedback is kept and the local education agency plan is adjusted accordingly for the school year and implementation is followed.

A meeting is held in the first quarter of the school year where the program is discussed. Parents, board members, administration, teachers, staff, and community members are invited to attend. A spring meeting is also held to follow up with the implementation of the plan and gather feedback for needs. The local education agency plan is discussed, suggestions are made and agreed upon to implement into the plan for the following school year.

In accordance with the policy, family engagement activities are scheduled for the school year including a Fall Family Learning Night where students enjoy educational Fall games while parents learn how to encourage reading and math activities at home through a parent/teacher session. In addition, an additional Winter or Spring Family Learning Night is held and stations are set up for students and families to work on activities together. These family engagement strategies are included in our plan.

Describe annual evaluation

At the Spring Family Learning Night parents are asked to complete a survey to evaluate the content and effectiveness of the Title I program. The survey focuses on the areas of School Planning, School-Home Communication, Helping your Child with School, and Parent Participation. Parents in attendance completed the survey and their name was placed in a drawing.

Describe method(s) for identifying barriers

The district uses district data to identify children that may be economically disadvantaged. Teachers follow a direct parent communication plan and keep logs of these communications with parents. Parents are invited to participate in family engagement events with direct phone calls from Adair County R-1 Staff. Parents and students are also offered extra academic time after school through teacher tutoring programs. Students who are identified as disadvantaged are also provided weekly snack packs through the Adair County Food Banks. Every student is provided with a daily snack by the Adair County YMCA. The district has no limited English proficiency students at this time.

Describe method(s) for identifying needs

The school has implemented a policy to interact with students who are struggling academically. Teachers make bi-weekly phone calls to parents of students who are at-risk academically. During these phone calls teachers log what topics they communicate with the parents. These topics may include homework strategies, suggestions, or offering extra services to help the student be successful. The administration reviews all logs and also at times requests meetings with these parents when the first form of communication is not successful. A fall parent-teacher conference is held for all students to review current fall data and suggest ways parents could engage in learning with their children to best support them academically. Monthly data meetings are held among Title I teachers to pick best strategies for the needs presented in Communication Arts and Reading Data.

Describe method(s) for identifying strategies

The school has implemented a policy to interact with students who are struggling academically. Teachers make bi-weekly phone calls to parents of students who are at-risk academically. During these phone calls teacher's log what topics they communicate with the parents. These topics may include homework strategies, suggestions, or offering of extra services to help the student be successful. The administration reviews all logs and also at times requests meetings with these parents when the first form of communication is not successful. A fall parent-teacher conference is held for all students to review current fall data and suggest ways parents could engage in learning with their children to best support them academically. The school holds a back to school open house in the fall that allows all parents and students to meet teachers and interact. A fall and spring Family Learning Night is held each year to promote family interaction with education.
